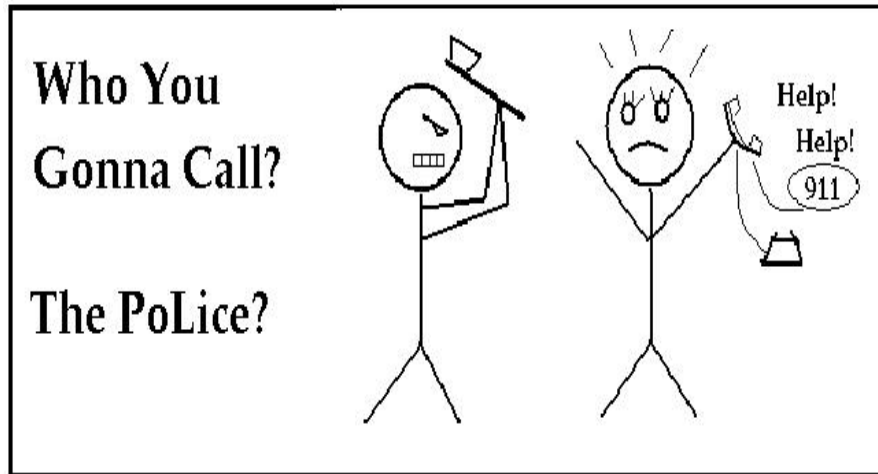
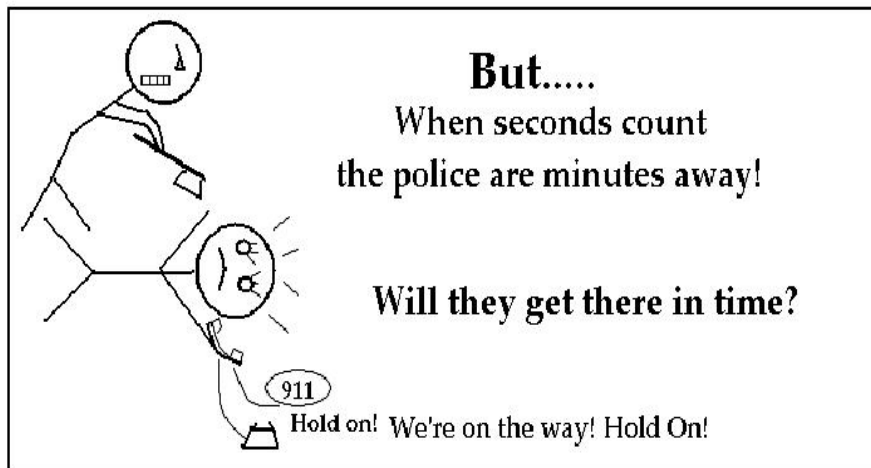


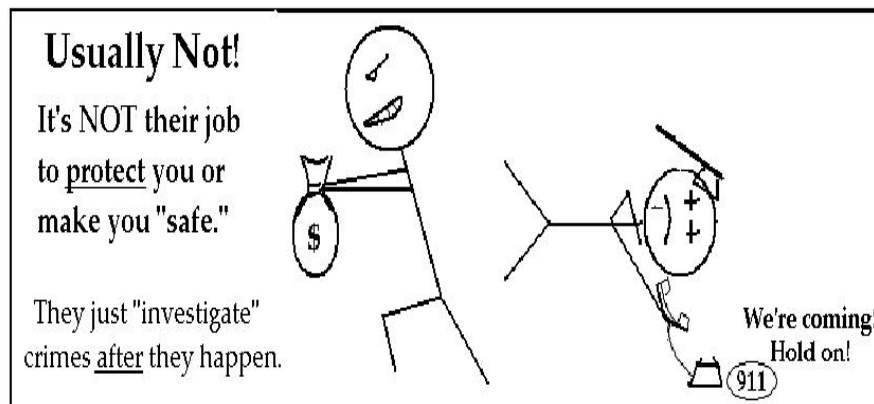
Real Life Problems & the Realities about “the law!”

Did You Know...?

When you're faced with a life-threatening situation, the kind where you'd always call "911" (if you only could,) it normally takes the "first responders" a minimum of 6 minutes to get to your location and maybe longer before they actually "help." (And that's considered a fast response!)

How long do you think it takes for a bad-guy to do the "*bad thing*"?

Bad things happen in seconds! When seconds count, the police are *minutes* away!

What are you going to do while you wait for help to come?

What do you *think* that bad-guy is going to be doing in all that time?

Well, did you also know...

that the police, the courts and **all** the *authorities* know that your personal safety and protection is *your own* responsibility?

It's not their job to make you safe! (And it *never* was!)

You have no right to expect the police or anyone else to come to your rescue at all. That is the law!

Anyone saying otherwise is lying or just doesn't know the facts.

There is no middle ground on this subject!

When the bad thing is happening you are on your own!

These scary facts are all very True!!

All the court cases on this subject, (including the US Supreme Court,) have made it clear that you're on your own with the bad-guys.

How you defend yourself from a bad-guy that threatens you is entirely up to you. There are no rules. It's not a game.

Self-defense is never denied. That is the law too!

It's one of the oldest principles of law in the whole wide world.

A jury will decide your fate and they usually *don't* know their job!

If a jury doesn't know its job and/or is improperly instructed by the presiding judge, (as commonly happens,) you could go to jail for the rest of your life for simply defending yourself or the lives of your loved-ones or your property and *especially* if you went to the aid and assistance of some *other person* who was in danger, (*that's really bad!*)

Many people are in prison today for doing "*the right thing!*" Only the jury can save you from prison *when you've done no wrong.*

Sadly, juries seldom understand their purpose in our justice system.

What every resident-member of this country should know... is that juries are *supposed* to decide whether or not the defendant actually did something *wrong!* That's more important than the letter of the law! They don't need a judge to tell them its okay. They just *can* !!

The legal community hates this and disdainfully snarl out the words "jury nullification" implying that the jury did something wrong in reaching such a decision.

What *really* happened on these *rare* occasions is that justice actually gets served in the manner that's clearly intended by our wonderful constitution.

The whole purpose of the jury is to decide whether or not something happened that requires punishment! They were *not* expected to be overly concerned with the "letter of the law." That's why the jury was supposed to be selected of your "peers" (people of the same *class* as the accused) which rarely happens.

A jury is *supposed* to decide much more than just innocence or guilt but are carefully told otherwise by the judge.

Defense against any aggressor is never *wrong, even when its against* the "*jack-booted thugs!*" **Remember these things!**

You (the individual) are the only person responsible for your safety and protection. That was never what the Police were for. They're *NOT* your friends.

When a jury finds a man guilty of *the crime of* defending his life, home or family there is something very wrong with how they were instructed by the judge.

Self-Defense is *never* wrong! Never!

The jury of a trial can decide more than innocence or guilt. They can also decide whether or not the law should even be applied to that particular case. Judges usually (wrongfully) instruct juries to only answer the question of did he or did he not do *the thing* and to *ignore* the rest of the matter.

The judges *should* tell juries to consider all the facts and decide whether or not the man did anything *so wrong that he should be punished*.

They can decide if the law should apply to that case at all. If you ever serve on a jury...

remember, you get to decide if the accused really did *something wrong*.

If the defendant was just trying to keep from being robbed or harmed or helping another against those things, he probably didn't really do anything wrong!

Don't be shy about saying... "Not Guilty!"
